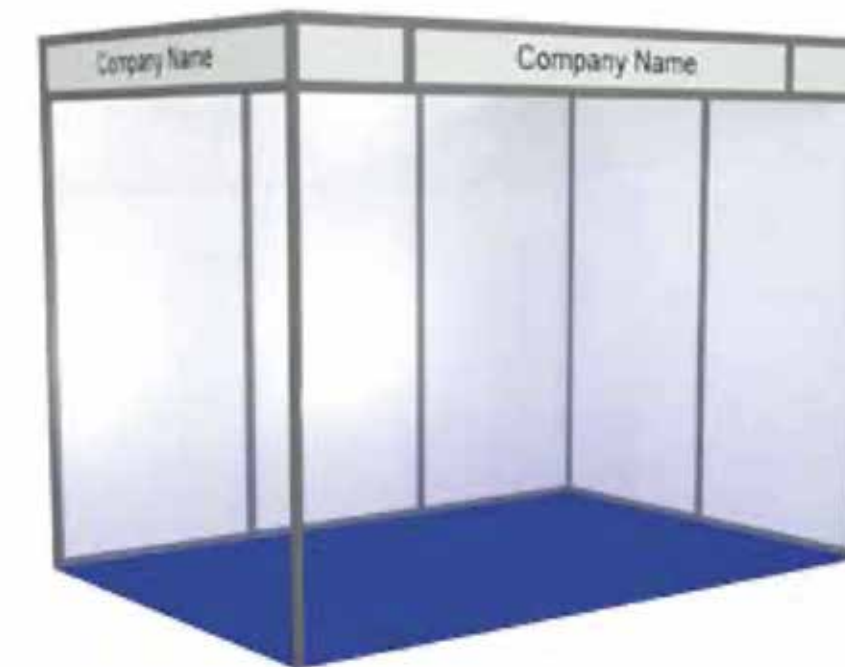

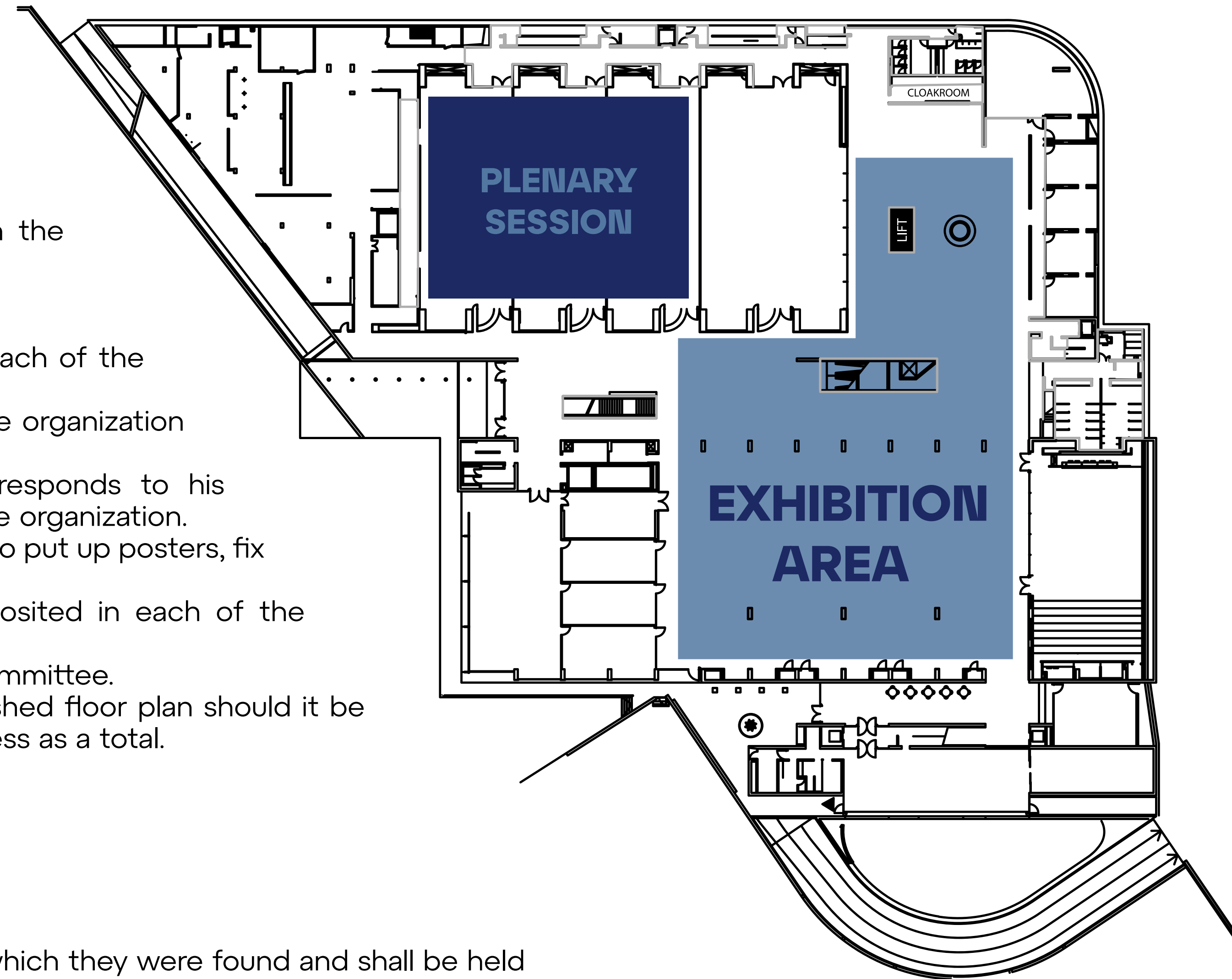
Exhibition area Terms and Conditions:

CANCELATION POLICY FOR REGISTRATION

All cancellations must be faxed, electronically mailed or postmarked. Refund of registration fees will be as follows:

Before Feb. 20, 2026 – 100% refund (minus € 50 handling fee)

From Feb. 21, 2026 – 50% refund

No refund on cancellations received after Apr. 1, 2026

In the event of pandemic and/or declaration of a State of Alarm, or the free movement of attendees within Spanish territory is prevented, in the event of total cancellation or postponement, the registration fee will be fully refunded, except for €50 in management fee concept.

TERMS AND CONDITIONS

REQUEST TO PARTICIPATE

Only applications to participate received in the corresponding forms duly completed will be considered, and on a first come first serve basis.

Applicants will be informed in writing of the acceptance or rejection of their applications. In case of rejection, all payments will be refunded. In the event of acceptance, the sponsors / exhibitors will be bound by the terms and conditions listed in the brochure and / or the contractual agreement. Once the conditions are accepted, the exhibitor or sponsor will not be entitled to any financial refund if they decide to cancel their contract.

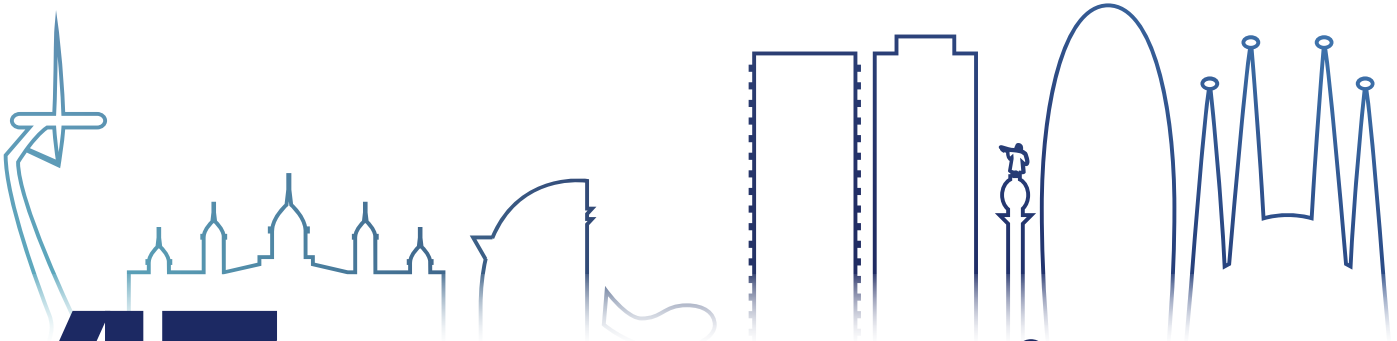
